### ❖ Review of Subsidy Rates for FY 2025-2026

The Employer subsidy rates are determined by GSF's Actuary (and approved by the Minister of Finance), taking into account the cost of providing future inflation-adjusted benefits to members, spouses and children. Employer subsidy rates are reviewed annually and adjusted where there is an actuarial justification for doing so.

Your organisation should have received a letter from Datacom in February 2025 confirming the 2025/2026 subsidy rate to apply to GSF subsidy calculations from the first full pay period after 1 July 2025. Please contact us if you did not receive a copy of the subsidy rate letter, if you wish to confirm your subsidy rate or if you require any further information about GSF subsidy rates.

We would like to inform you that going forward, the Employer subsidy rate letter will be sent by email rather than the traditional postal mail. This change is being implemented to enhance efficiency, reduce environmental impact, and provide quicker delivery of important information to all GSF employers. Email allows us to reach you instantly, reducing delays associated sending the letter by post.
